

## ANNEX II

### APPOINTMENT OF AUTHORISED REPRESENTATIVE

**Informative Memo:** in accordance with article 20.2 of Delegated Regulation (EU) 2019/1122, the account must have at least two authorised representatives designated at the time of opening, who may have the following rights regarding the execution of processes from the account (including transactions):

1. **ROLE 1 (READ ONLY):** they can only access the account for consultation purposes and they cannot initiate or approve any process.
2. **ROLE 2 (PROCESS INITIATOR ONLY):** they can only start processes from the account (i.e.: propose a transaction), which must be approved by a **ROLE 3** or **ROLE 4**.
3. **ROLE 3 (PROCESS APPROVER ONLY):** they can only approve processes already started by another **ROLE 2** or **ROLE 4**.
4. **ROLE 4 (PROCESS INITIATOR AND APPROVER):** they can initiate processes (which must be approved by another **ROLE 3** or **ROLE 4**) and approve the processes initiated by another **ROLE 2** or **ROLE 4**. They cannot approve self-initiated processes.

In order for the processes to run, one of the following combinations of authorised representatives must be marked:

1. **ROLE 2 + ROLE 3**
2. **ROLE 4 + ROLE 3**
3. **ROLE 2 + ROLE 4**
4. **ROLE 4 + ROLE 4**

Any other combination of authorised representatives other than those mentioned may not be requested.

- Data recipients:** neither data assignments nor international data transfers are provided for.
- Data processing rights:** In accordance with the provisions of articles 13 to 18 of Substantive Law 3/2018, of December 5, Protection of Personal Data and guarantee of digital rights and articles 15 to 22 of General Regulation (EU) 2016/679 of Data Protection.
